2. The MCRC intends on purchasing these materials when they perform pavement repairs, pavement patches, wedging, and other work activities that require HMA mixtures.					
3. MCRC will need to consider project site locations and needs when deciding where to purchase the HMA materials and verify if the plants are producing material on the specific days needed. MCRC trucking costs are a main consideration when determining where to purchase the materials. Will likely purchase the HMA materials from Ron Brown & Sons when HMA is needed for routine pavement patching of large potholes using our 2 ton or 4 ton capacity hot patchers (subject to their current HMA material prices).					
The 2023 HMA Paving and Patching Materials were awarded to all three of the bidders during the Manistee County Board of County Road Commissioners regularly scheduled Board Meeting on March 8, 2023 MCRC staff will decide where to purchase the HMA materials based on the MCRC needs, projects, type of materials needed, and the project locations in the best interest of the MCRC
