Type: Two Wheel Drive (2WD) Heavy Duty One-ton Crew Cab Pickup Truck Cab & Chassis with Dual Rear Wheels

Note: A 2-3 Yard 9' long Crysteel Dump Box and lift will be installed by others so the chassis dimensions must accommodate the proposed dump box

Model Year: 2018

Exterior Color: Red (state actual color with bid)

Interior Material and Color: Vinyl with dark colors (state actual colors with bid)

Seats: 40/20/40 front seats (or bucket with console) and rear bench seats

Engine: V8 6.0 liter (minimum) gas engine (state type of engine and specifics with bid)

Transmission: Automatic

GVWR: State GVWR weight with bid

Rear Wheels: Dual Rear Wheels (DRW), Wide Track

Rear Axle Ratio: State ratio with bid

Wheels and Tires: Wheels with All-Season black-wall tires
(state size and type of wheels and tires)

Additional Equipment:

2. Radio upgrade for "blue tooth" (for cell phones hands free communications)
3. Basic Compass for navigation

Delivery Cost: State the delivery cost to deliver the vehicle to the Manistee County Road Commission in Bear Lake, Michigan if the MCRC decides to have it delivered

Delivery (or Pickup) Date: The bids shall specify the delivery date as the number of calendar days from the date of award of the bids by the Manistee County Road Commission (MCRC) to delivery of the vehicle to the MCRC yard in Bear Lake, Michigan (or that the vehicle is ready for pick by MCRC, if MCRC chooses this option).

- 2. Bidder shall indicate if Mi-Deal pricing
