Type: Four Wheel Drive (4WD) Three-quarter Ton Crew Cab 4-Door Pickup Truck  
(State type and model with bid)

Exterior Color: Red (state actual color with bid)

Interior Material and Color: Black cloth seats (state actual colors with bid)

Seats: 40/20/40 front seats (or bucket with console) and rear bench seats

Engine: V8 gas engine (6.0 liter minimum) with active fuel management, direct injection, and variable timing (state type of engine and specifics with bid)
